

WELCOME ABOARD!

WHO CAN RIDE?

General Public may board the scheduled fixed-route service at the shuttle stops indicated on the service schedule.

Senior Citizens (60+) and persons with disabilities can schedule pickup/dropoff in each community during the time indicated on the service schedule for curb-to-curb service.

Contact the service provider to schedule curb-to-curb service. Schedule your trip at least **24-hours in advance**. You may schedule your trip up to **one week in advance**. First time riders are required to show their ID to the driver to verify eligibility. If the driver cannot visually verify disability, then the driver may request a letter from a physician describing the disability.

Children under the age of 12 must be accompanied by an adult 18 years of age or older.

WHAT IS THE COST?

This shuttle service will be provided free of charge to seniors (60 years of age or older), persons with disabilities, and children under the age of 5 years when accompanied by an adult. All others will be charged a \$1 fare.

PLEASE NOTE:

- All certified service animals for persons with disabilities are allowed on the vehicle.
- No eating, drinking or smoking in the vehicle.
- Wheelchair passengers, for your safety, we request that you are secured by a vehicle lap belt.


