- Licenses, certificates or affidavits showing your qualifications of experience in Los Angeles County or elsewhere, sufficient to provide a minimum of 4 years of certified experience. Testimonial letters from prior employees must be on business letterheads indicating state plumbing contractor's license number. Letter shall be the original and shall be notarized. If you are working in a large plant or factory, your experience must be under a State licensed plumbing contractor or a licensed journeyman plumber. The contractor, or journeyman plumber along with the plant manager must certify your experience on a notarized letter, signed by both, with the license number of the contractor or journeyman plumber, and the location of the plant clearly indicated on the letterhead.

Your examination will be based on general knowledge of plumbing, water piping, gas fitting and sewage disposal, and on the specific requirements of the **2006** Uniform Plumbing Code.

YOUR COMPLETION OF THE EXAMINATION WITHIN THE TIME ALLOTTED WILL DEPEND ON A THOROUGH WORKING KNOWLEDGE OF THE UNIFORM PLUMBING CODE, YOUR ABILITY TO READILY LOCATE INFORMATION THEREIN, AND TO ANSWER QUESTIONS AND WORK EXAMPLES BASED THEREON.

- 1. Examinees must have with them and may use a copy of the 2006 Uniform Plumbing Code for reference purposes. **No other reference material will be permitted**.
- 2. Examinees making an aggregate grade of less than 70% are automatically failed and shall pay the application fee to re-take the examination. Those making an aggregate grade of 70%, but failing to attain a grade of at least 70% on any phase of the examination may be continued for further examination at the next regular meeting at the discretion of the Board without additional fee. It shall be considered a failure of the entire examination if a grade in any of the re-taken sections is less than 70%.
 - Any applicant who fails the retaken section must wait 6 months before being permitted to pay the application fee and take the examination again.
- 3. Examinees will be allowed two hours for the written examination. An oral interview may be required at the examiner's discretion.
- 4. You will not be permitted to take the examination until acceptable proof of four (4) years prior experience is furnished.
