



**NOTICE OF COMMUNITY MEETINGS REGARDING THE  
PROPOSED NON-EXCLUSIVE COMMERCIAL TRASH  
COLLECTION FRANCHISE WITHIN UNINCORPORATED  
AREAS OF LOS ANGELES COUNTY**



Currently, trash collection services for bins (or dumpsters) and roll-off boxes within the unincorporated areas of Los Angeles County (outside the County's Garbage Disposal Districts and cities) are provided in an open-market system where customers directly arrange for services with waste haulers and not with the County. However, this system is unable to adapt to changes in State law and customers' desire for enhanced services.

Effective July 1, 2012, state law requires all applicable bin (or dumpster)/roll-off customers to subscribe to recycling services. As a result, a Draft Non-Exclusive Commercial Franchise Agreement (Agreement) has been completed. The Agreement ensures all customers receive quality service as well as recycling services as mandated by the State. The Board of Supervisors will consider adoption of the Agreement in spring 2012. Once adopted, all waste haulers operating within the unincorporated areas of the County (excluding the County's Garbage Disposal Districts and cities) must sign the Agreement in order to provide services to properties that utilize bins (or dumpsters) and roll-off boxes.

The Agreement is available for review through February 1, 2012 at Los Angeles County, Department of Public Works, Environmental Programs Division, 900 South Fremont Avenue, Annex 3rd Floor, Alhambra, California 91803 and on the internet at [www.CleanLA.com](http://www.CleanLA.com). In addition, Public Works has scheduled community meetings to ensure all stakeholders are given an opportunity to provide input and ask questions regarding the Agreement.
