## LOCAL ASSISTANCE CENTERS SET TO OPEN IN LA CRESCENTA & LONG BEACH – FEB. 23

The Los Angeles County Operational Area, comprised of 88 cities, 137 unincorporated areas and more than 200 special districts, in coordination with the U.S. Small Business Administration (SBA) and California Emergency Management Agency (CalEMA) will open Local Assistance Centers (LACs) in La Crescenta and Long Beach beginning on Tue., Feb. 23.

The LACs are available to all residents impacted by the recent flooding and debris and mudflow. The centers will serve as a one-stop source for information including on how to replace records lost in the winter storms, file insurance claims and apply for assistance. The Local Assistance Centers will provide a single place for the victims of the recent winter storms to receive help and get them on the road to recovery. No direct assistance will be provided or donations accepted at the LACs.

The Local Assistance Centers are scheduled to be open from Feb. 23-27. The days and hours of operations: Weekdays (9 a.m. to 7 p.m.), Sat. (9 a.m.-4 p.m.) and Sun. (Closed). The days and hours may be subject to change.
