AV IRWMP First DAC Outreach Committee Meeting Wednesday, April 18, 2012

The first Antelope Valley Integrated Regional Water Management Plan (IRWMP) 2007 Update DAC outreach committee meeting was held on April 18, 2012, at Palmdale Water District, 2029 E. Avenue Q, Palmdale, CA 93550.

1. Welcome and Introductions

- a. The meeting was opened and led by Brian Dietrick (RMC); called to order at 11:15 am.
- b. Electronic copy of the power point presentation is attached.

2. DAC Meeting Objectives

- a. Brian went through the meeting objectives. These included:
 - i. Prop 84/1e requirements
 - ii. Previous DAC work
 - iii. Six previously identified DACs
 - iv. DAC Committee schedule
 - v. Outline of first DAC deliverable
 - vi. Next steps

3. Prop 84/Prop 1E DAC Info

- a. Brian summarized the importance of DAC involvement in IRWMP updates:
 - i. DWR requirement for project prioritization
 - ii. DWR requirement for outreach component
 - iii. DAC planning projects are eligible for implementation funding under Prop. 84, Round 2 (non-DAC planning projects are not)
- b. DAC communities are characterized as communities with median household income less than 80 percent of the statewide median
 - i. Stakeholders requested to know what the current 80 percent statewide household median is, RMC to obtain this information
 - ii. No other requirements are necessary to be considered a DAC

4. DAC Background

a. Brian reviewed the DAC work/information presented in the 2007 IRWMP

- In the 2007 IRWM Plan no DAC projects were developed. For the IRWMP update AV IRWMP Region should consider including DAC projects
- b. Jennifer Wong (DWR) announced the DWR site has an IRWMP map which identifies DAC regions. However, the site has not been working properly. Jennifer to look into the issue.
 - RMC to compare identified 2007 DAC communities to the DWR IRWMP DAC map
- c. DAC projects must be water-related to qualify for Prop 84 funding

5. Lake Los Angeles (Unincorporated County)

- a. Contact person: Kristi Kennedy (Lake LA Town Council)
- b. Issues (updated from 2007 IRWMP):
 - i. Flood control: Flooding in the region has caused property damage and traffic issues; mostly Big Rock Creek
 - ii. Septic Systems: All residents are on septic system; currently there are no sewer lines; previous discussions indicated some installed but unused sewer pipes but no one on the committee was aware of existing pipes
 - iii. Water Supply: region concerned about restrictions on new wells; AVEK supply is not available to entire area
 - iv. Water Quality: Concerns over distance of water treatment facilities and water quality; concerns about well water quality in some areas
 - v. Water Rates: concerns about rising rates
- c. Rural Town Council (RTC)meeting: RMC to coordinate with Kristi Kennedy (Lake LA Town Council) before the next meeting to report to council on IRWMP effort and DAC outreach (to encourage people to get involved)
 - i. The RTC meetings are held every last Thursday of the month— RMC to obtain actual date of meeting from Kristi Kennedy (Lake LA Town Council)
 - ii. Stakeholders suggested someone non-local come in to give presentation during meeting
- d. Stakeholders suggested RMC contact the mutual water companies of this region to obtain information

6. Littlerock (Unincorporated County)

- a. Contact person: RMC to contact Wayne Argo, who should be able to provide RMC information on the most appropriate person for the Littlerock area
 - Kristi Kennedy (Lake LA Town Council) to obtain contact information for Anne Marie.
- b. Issues: Need to verify with Littlerock contact person if the 2007 IRWMP issues remain the same or need to be updated

c. Stakeholders suggested RMC contact the mutual water companies of this area to obtain information

7. Mojave (Unincorporated County)

- a. Contact Person: Stakeholders suggested RMC contact same people as in 2007-Chamber of Commerce, School District, Mojave Utilities District, Desert News
 - i. This area does not attend the RTC meetings (only LA County does)
 - ii. Stakeholders suggested RMC contact Rosamond, the Kern County Association (Vicki Nelson has contact information), and Anthony Languin from City of California City
- b. Issues: Need to verify with contact persons if the 2007 IRWM issues remain the same or need to be updated

8. Roosevelt (Unincorporated County)

- a. Contact Person: RMC to contact Wayne Argo, who should be able to provide RMC information on the most appropriate person for the Roosevelt area
- b. Issues: Need to verify with contact persons if the 2007 IRWM issues remain the same or need to be updated

- g. Committee members to review DAC Data TM and provide comments when draft version is ready




