6) Report on business other than appeals

Report on business other than appeals.

a) Safe Routes To School (SRTS) Grant

Ms. Guilmette provided a power point presentation entitled Safe Routes to School: Improving Health, Safety and Transportation. In this presentation, Ms. Guilmette informed the HSC that there is a need for Safe Routes to School because:

- Fewer kids today walk and bike to school and more parents are driving. Parents driving children to school account for 20% to 25% of morning traffic.
- Unintended consequences have resulted such as poor air quality and physical inactivity by our youth.
- SRTS programs are part of the solution.

The most common barriers to walking and bicycling to school are long distances, traffic danger, adverse weather and fear of crime danger. The SRTS program intends to do the following:

- Improve walking and bicycling conditions
- Increase physical activity
- Decrease air pollution
- Reduce congestion around schools
- Lead to cost savings for schools (need for school buses)
- Increase child's sense of freedom,
- Help establish lifetime habits, teach pedestrian and bicyclists skills

The elements of SRTS programs are:

- Education
- Encouragement
- Enforcement
- Engineering
- Evaluation

Ms. Guilmette informed the HSC that the County intends to apply for Cycle 2 of the Federal Safe Routes to School program. She stated that this application is due on July 18, 2008.
