What is IRWM planning?

A collaborative process to develop water management strategies by evaluating opportunities for multiuse projects to maximize regional benefits.

How did we get here?

- An attempt was made to develop an IRWM Plan for the Antelope Valley in 2005.
- There was not enough support to develop a regional plan at that time.
- Due to available Prop 50 Ch 8 funds and other potential future bond issues, we have convened this stakeholder group to initiate the preparation of an Antelope Valley IRWM Plan.

Recap of the May Meeting - Meeting Minutes

- We had three main presenters: LACDPW Watershed Management Division, Mojave Water Agency, and CA DWR.
- LACWWD's role in development of the IRWMP would be as a facilitator for the process.
- LACWWD will continue engaging the stakeholders throughout the process to maintain trust.

Formation of Regional Water Management Group

- Regional Water Management Group (RWMG)
 - Three or more local public agencies
 - Two of which have statutory authority over water supply
 - Participate by means of an MOU
- RWMG formation is needed
 - To adopt the IRWMP
 - To submit future grant applications

Formation of Regional Water Management Group

- Proposed RWMG's duties are
 - To provide and share all necessary and relevant information, data, studies, and/or documentation for the IRWMP development.
 - To review and comment on the draft and final versions of technical reports and the IRWMP.
 - To adopt the IRWMP.
 - To provide financial contribution towards the IRWMP development.
 - To prepare, review, and approve future grant applications for implementation of the adopted IRWMP.
