The County of Los Angeles (County) as the lead agency through its Department of Public Works has completed the Draft Program Environmental Impact Report (Draft PEIR) for the County of Los Angeles Bicycle Master Plan. The Draft PEIR is available for a 45-day public review and comment period starting **August 9, 2011**, and ending **September 23, 2011**. The Draft PEIR will be available for review at the Department of Public Works, Programs Development Division, 900 South Fremont Avenue, 11th Floor, Alhambra, California 91803. It can also be reviewed at www.dpw.lacounty.gov/go/bikeplan. Limited hard copies are available on a first request basis by contacting Ms. Reyna Soriano at the address or telephone number indicated herein.

The proposed Bicycle Master Plan would replace the 1975 Plan of Bikeways. The Bicycle Master Plan proposes a vision for a diverse regional bicycle system of interconnected bicycle corridors, support facilities, and programs to make bicycling more practical and desirable to a broader range of people in the County. It is intended to guide the development and maintenance of a comprehensive bicycle network and set of programs throughout the County's unincorporated communities for the next 20 years.

The Draft PEIR has identified significant impacts that may result from individual projects included in the Bicycle Master Plan (related to aesthetics/visual resources, biological resources, hydrology/water quality, cultural resources, hazards/hazardous materials, traffic/transportation, greenhouse gas emissions, and mineral resources). For each of these impacts, mitigation measures have been identified that could reduce these impacts to less than significant. The specific determination of the level of impacts and mitigation for individual projects will be made as these projects are implemented.
