ROADWAY IMPROVEMENT PROJECT DELAYED UNTIL APRIL 2013



Dear Neighbor:

The County of Los Angeles Department of Public Works regrets to inform you that the new roadway improvement project that was scheduled to begin in September 2012 will be delayed until April 2013. Recognizing the high volume on Del Amo Boulevard, construction activities were scheduled to be performed during weekday nights and over a series of weekend closures. The primary goal of this approach was to expedite the project and reduce construction impacts to the motoring public. Unfortunately, finalizing the details of the construction project took longer than anticipated. With winter soon upon us, we became concerned that rain and cold weather would disrupt our carefully scheduled construction operations, potentially causing delays and extending the impacts to motorists. As a result, we decided to reschedule the project to April 2013. We apologize for any inconvenience this may cause.

The attached map is provided for your information to outline the scope of the work to be performed. The work will be performed in the community of Rancho Dominguez and the Cities of Carson and Long Beach. The project is funded by the County of Los Angeles and the Cities of Carson and Long Beach. The project will benefit the entire region.

When we get closer to starting work, we will provide detailed construction information and closure schedules. 
