
ANNEXATION No 142, EAST EL MONTE UNINHABITED

THE CITY COUNCIL OF THE CITY OF EL MONTE DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. That pursuant to the "Annexation of Uninhabited Territory Act of 1939," as amended, the City Council of the City of El Monte, on its own motion, does hereby initiate proceedings for the annexation to the City of El Monte of certain uninhabited territory contiguous and adjacent to the City Limits of the City of El Monte and situated near the easterly portion of the City of El Monte, as more particularly described in Section 5 hereinafter.

Section 2. That the City Council of the City of El Monte desires to annex such uninhabited territory to promote and insure the harmonious development and use of the area proposed to be annexed and the proper integration of said territory with the contiguous area already within the limits of the City of El Monte.

Section 3. That the proposal for the annexation of said territory to the City of El Monte has been submitted to and favorably reported upon to the proponents by the Boundary Commission of the County of Los Angeles with respect to the definiteness and certainness of the proposed boundaries, pursuant to Section 35002 of the Government Code of the State of California.

Section 4. That the said territory is uninhabited and is contiguous to the City of El Monte and is not a part of any other municipal corporation.

Section 5. That pursuant to the "Annexation of Uninhabited Territory Act of 1939," as amended, the City Council of the City of El Monte does hereby give notice of said proposed annexation; that said territory shall be and objections to the proposed an-

nexation may appear before the City Council of the City of El the same is hereby designated for identification purposes as "Annexation No. 142, East El Monte Uninhabited", and is particularly described as follows:

All that property in the County of Los Angeles, State of California, bounded and described as follows:

Beginning at the intersection of the boundary of the City of El Monte, as same existed on October 29, 1957, said boundary being the northeasterly line of Ferris Road, 60 feet wide, as shown on Map of Tract No. 10710, as per map recorded in Book 192, Pages 19 and 20 of Maps in the Office of the County Recorder of said County, with the northeasterly prolongation of the northwesterly line of Lot 1 of said Tract No. 10710; thence southwesterly along said prolonged line and the northwesterly line of said Lot 1 to the most westerly corner of said Lot 1; thence southeasterly in a direct line to the most southerly corner of Lot 2 of said Tract No. 10710; thence northeasterly along the southeasterly line of said Lot 2 to the southwesterly line of said Ferris Road; thence northwesterly along the southwesterly line of said Ferris Road to the most northerly corner of said Lot 2; thence northeasterly along the northeasterly prolongation of the northwesterly line of said Lot 2 to the northwesterly line of said Ferris Road; thence northwesterly along the northwesterly line of said Ferris Road to the point of beginning.

Section 6. That the City of El Monte hereby gives notice of and fixes March 17, 1958, at the hour of 7:30 P. M., in the Council Chambers of the El Monte City Hall, 511 East Valley Boulevard, El Monte, California, as the day, hour and place when and where any person owning real property within such territory so proposed to be annexed and having any Monte and show cause why such territory shall not be annexed.

Section 7. The City Clerk of the City of El Monte shall certify to the adoption of this resolution, and shall cause a copy hereof to be published at least twice, but not oftener than once a week in the El Monte Herald, a newspaper of general circula-

tion published in the City of El Monte, said publication to be complete at least twenty days prior to the date set for the hearing aforesaid, and the City Clerk shall cause written notice of such proposed annexation to be mailed to each person to whom land within the territory proposed to be annexed is assessed in the last equalized county assessment roll available on the date the proceedings were initiated, at the address shown on said assessment roll or as known to said City Clerk, and to any person who has filed his name and address and the designation of the land in which he has any interest, either legal or equitable, with said City Clerk, such notice to be given not less than 20 days before the first public hearing on the proposed annexation.

Section 8. Notice is further given that at said time and place, and in connection with said hearing on said annexation, the City Council will consider the recommendation of the City Planning Commission that, concurrent with such annexation, interim emergency zoning be adopted placing said territory in Zone R-3 under the zoning regulations of the City of El Monte, and the request of the property owners that the property be placed in Zone R-3 and Zone C-2.
