By an election held August 27, 1925, Ord. No. 52809 approving the annexation adopted Sept. 15, 1925, and notice filed with the Secretary of State, Oct. 26, 1925, the following described territory was annexed:

Beginning at the most easterly corner of Tract No. 1033, Sheet No. 1, as per map recorded in Book 17, pages 90 and 91 of Maps, Records of Los Angeles County, said corner being also a point in the boundary of the City of Los Angeles as said boundary existed March 1, 1925; thence southwesterly along said boundary to the most southerly corner of Lot "A" Tract No. 3123, as per <sup>map</sup> recorded in Book 32, page 36, of Maps, Records of said County, said last mentioned corner being also a point in said boundary; thence northwesterly along said boundary of the City of Los Angeles and continuing along the same in all of its various courses to the point of beginning, said parcel of land being the same parcel made as an exception in the Laurel Canyon Addition described in Ordinance No. 45,687 (New Series) of said City.
