A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CERRITOS, CALIFORNIA ADOPTING AN OFFICIAL MAP FOR A PORTION OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 31, TOWNSHIP 3 SOUTH, RANGE 11 WEST, WITHIN THE PERIMETER OF THE RECORD OF SURVEY IN BOOK 85, PAGE 47 OF RECORDS OF SURVEY FILED IN THE LOS ANGELES COUNTY RECORDER'S OFFICE.

WHEREAS: THE CITY COUNCIL OF THE CITY OF CERRITOS HAS CAUSED SAID MAP TO BE PREPARED TO DELINEATE THE PORTION OF THE CERRITOS CIVIC CENTER DEVELOPED BY THE REDEVELOPMENT AGENCY OF THE CITY OF CERRITOS.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CERRITOS DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. IT IS HEREBY ORDERED THAT SAID MAP CONSISTING OF ONE SHEET BE APPROVED AND ADOPTED AS OFFICIAL MAP NO. 1, OF THE ABOVE CITY AREA IN ACCORDANCE WITH THE PROVISIONS OF DIVISION 3 OF THE GOVERNMENT CODE SECTIONS 66499.50 TO 66499.58 INCLUSIVE FOR THE USES AND PURPOSES THEREIN NAMED.

SECTION 2. THE EASEMENTS SHOWN ON SAID MAP FOR SANITARY SEWER, STORM DRAIN, INGRESS AND EGRESS PURPOSES SHALL BE RESERVED FOR PUBLIC USE AND ARE DELINEATED AND THEIR USE IS INDICATED ON SAID MAP.

SECTION 3. THE CITY CLERK OF THE CITY OF CERRITOS HEREBY IS DIRECTED TO ENDORSE ON THE FACE OF SAID MAP THIS RESOLUTION ATTESTED BY THE OFFICIAL SEAL OF THE CITY OF CERRITOS, AND IS ALSO DIRECTED TO CAUSE SAID ENDORSED MAP TO BE RECORDED IN THE LOS ANGELES COUNTY RECORDER'S OFFICE.

SECTION 4. THE CITY ENGINEER IS DIRECTED TO CERTIFY THAT SAID MAP COMPLIES WITH THE PROVISIONS OF DIVISION 3 OF THE GOVERNMENT CODE SECTIONS 66499.50 TO 66499.58 INCLUSIVE.

SECTION 5. THE CITY CLERK SHALL CERTIFY TO THE ADOPTION OF THIS RESOLUTION.
