**Summer Effective Quantity Adjustment** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 2000 cubic feet, but less than or equal to 6500 cubic feet is \$0.093 (additional 5% adjustment on the regular Quantity Charge).

**Summer Excessive Surcharge** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 6500 cubic feet is \$0.927 (additional 50% surcharge to the regular Quantity Charge).

**Winter Conservation Credit** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of the monthly allowance, but less than or equal to 1500 cubic feet is \$0.185 (10% off the regular Quantity Charge).

**Winter Effective Quantity Adjustment** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 1500 cubic feet, but less than or equal to 3000 cubic feet is \$0.093 (additional 5% adjustment on the regular Quantity Charge).

**Winter Excessive Surcharge** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 3000 cubic feet is \$0.927 (additional 50% surcharge to the regular Quantity Charge).

Service Charge includes 500 cubic feet of water per billing unit per month.

**Surcharge for Facility Construction**

**Summer Effective Quantity Adjustment** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 2000 cubic feet, but less than or equal to 6500 cubic feet is \$0.093 (additional 5% adjustment on the regular Quantity Charge).

**Summer Excessive Surcharge** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 6500 cubic feet is \$0.927 (additional 50% surcharge to the regular Quantity Charge).

**Winter Conservation Credit** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of the monthly allowance, but less than or equal to 1500 cubic feet is \$0.185 (10% off the regular Quantity Charge).

**Winter Effective Quantity Adjustment** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 1500 cubic feet, but less than or equal to 3000 cubic feet is \$0.093 (additional 5% adjustment on the regular Quantity Charge).

**Winter Excessive Surcharge** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 3000 cubic feet is \$0.927 (additional 50% surcharge to the regular Quantity Charge).

The Quantity Charge for each 100 cubic feet of water used in a month in excess of the monthly allowance is \$2.048.

**Summer Conservation Credit** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of the monthly allowance, but less than or equal to 2000 cubic feet is \$0.205 (10% off the regular Quantity Charge).

**Summer Effective Quantity Adjustment** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 2000 cubic feet, but less than or equal to 6500 cubic feet is \$0.102 (additional 5% adjustment on the regular Quantity Charge).

**Summer Excessive Surcharge** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 6500 cubic feet is \$1.024 (additional 50% surcharge to the regular Quantity Charge).

**Winter Conservation Credit** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of the monthly allowance, but less than or equal to 1500 cubic feet is \$0.205 (10% off the regular Quantity Charge).

**Winter Effective Quantity Adjustment** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 1500 cubic feet, but less than or equal to 3000 cubic feet, effective January 2008, is \$0.102 (additional 5% adjustment on the regular Quantity Charge).

**Winter Excessive Surcharge** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 3000 cubic feet is \$1.024 (additional 50% surcharge to the regular Quantity Charge).

Service Charge includes 500 cubic feet of water per billing unit per month.

**Surcharge for Facilities Construction**

**Summer Conservation Credit** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of the monthly allowance, but less than or equal to 2000 cubic feet is \$0.215 (10% off the regular Quantity Charge).

**Summer Effective Quantity Adjustment** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 2000 cubic feet, but less than or equal to 6500 cubic feet is \$0.108 (additional 5% adjustment on the regular Quantity Charge).

**Summer Excessive Surcharge** for each 100 cubic feet of water used in summer months (three consecutive two month billing cycles) in excess of 6500 cubic feet is \$1.076 (additional 50% surcharge to the regular Quantity Charge).

**Winter Conservation Credit** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of the monthly allowance, but less than or equal to 1500 cubic feet is \$0.215 (10% off the regular Quantity Charge).

**Winter Effective Quantity Adjustment** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 1500 cubic feet, but less than or equal to 3000 cubic feet, effective January 2008, is \$0.108 (additional 5% adjustment on the regular Quantity Charge).

**Winter Excessive Surcharge** for each 100 cubic feet of water used in winter months (three consecutive two month billing cycles) in excess of 3000 cubic feet is \$1.076 (additional 50% surcharge to the regular Quantity Charge).

Service Charge includes 500 cubic feet of water per billing unit per month.

#### **Surcharge for Facility Construction**

A rate of \$0.094 per 100 cubic feet for all water sold, including service charge allowance, shall apply on all WATERWORKS DISTRICT NO. 40 service zones.
