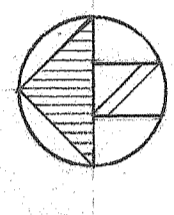
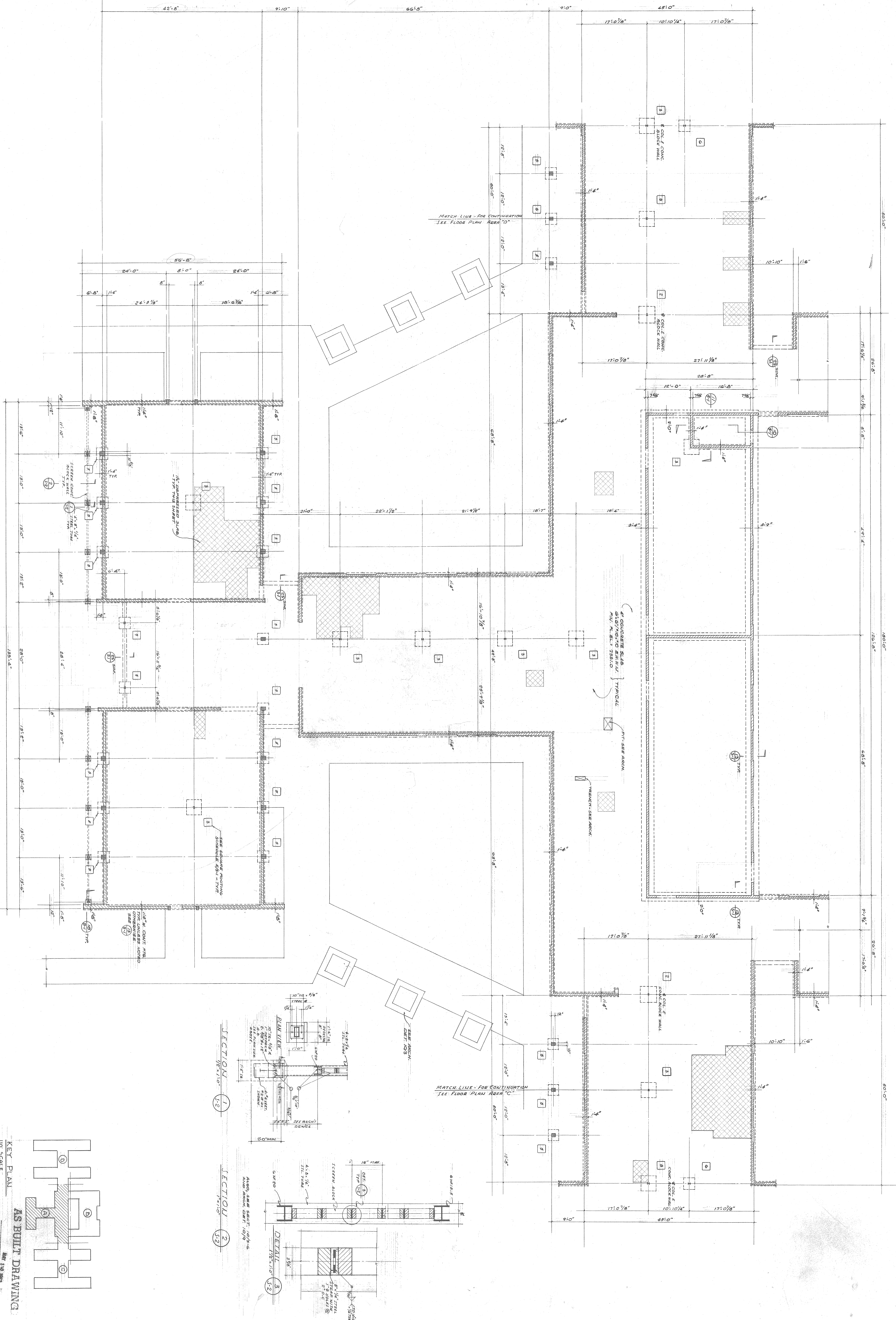

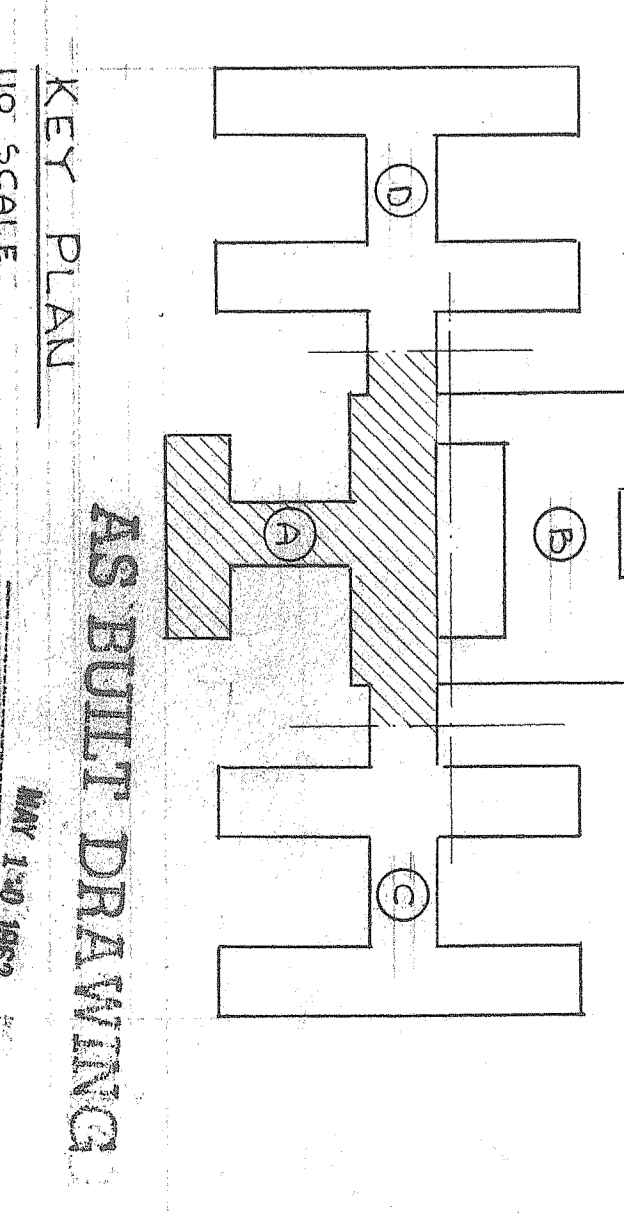


FOUNDATION & FIRST FLOOR PLAN AREA "A"

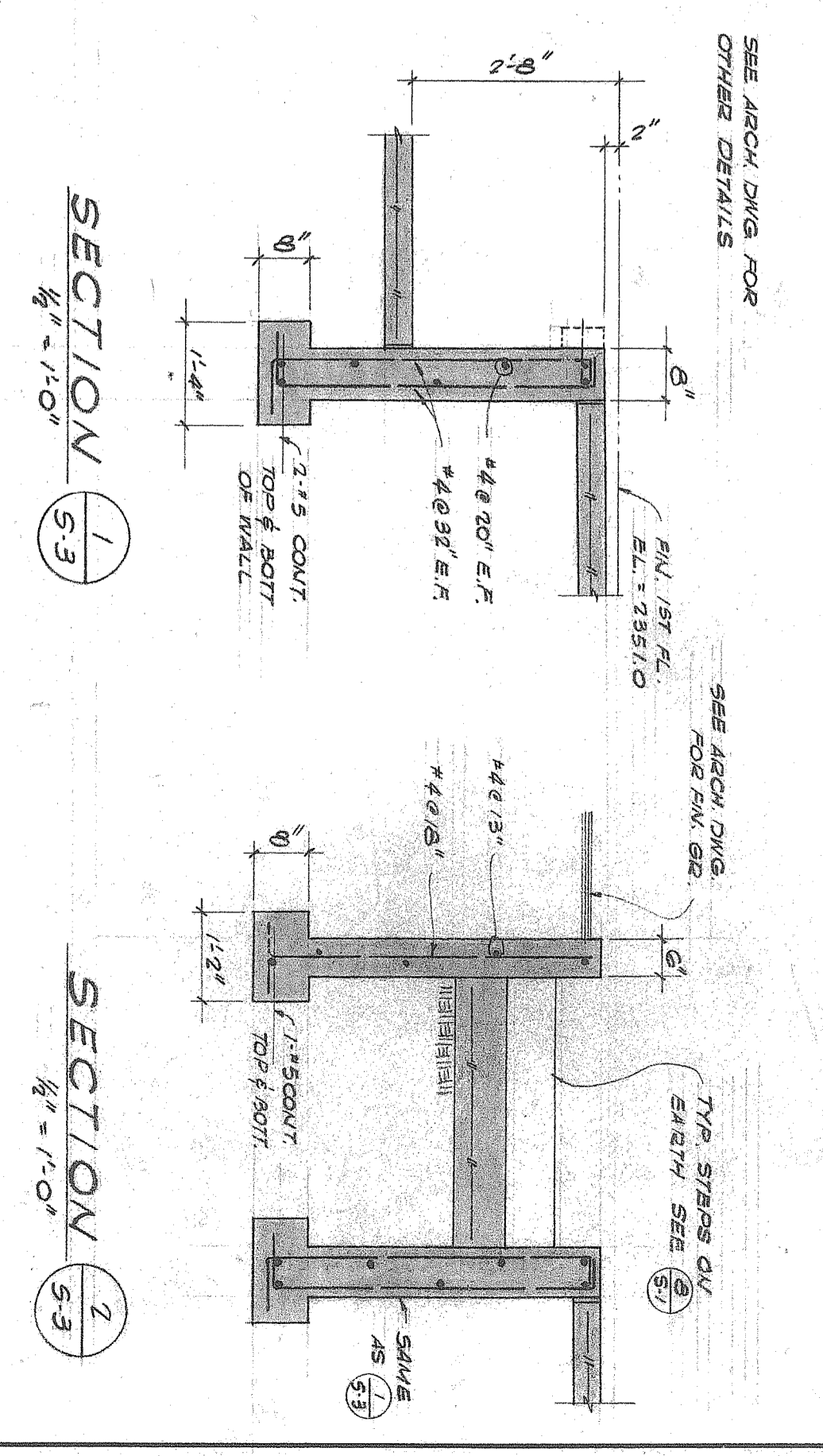


FOUNDATION & FIRST FLOOR PLAN AREA "B"

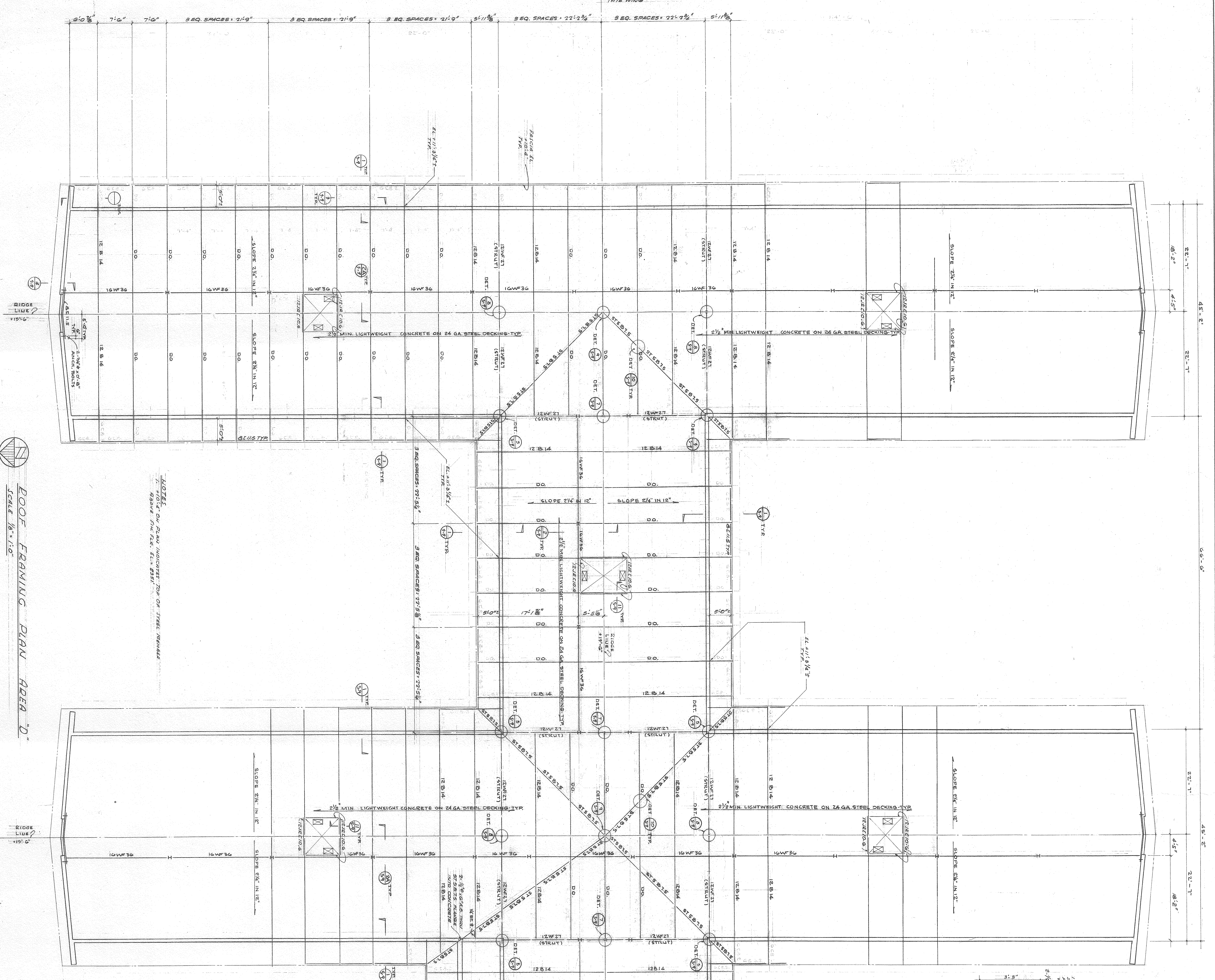
ROOF FRAMING PLAN AREA "C"
