QUESTIONS:

Question 1: Plans call for a concrete footing for Green Screen per Sheet/Detail A6.0/7 and Sheet/Detail A7.0/2 but Additive Alternate #1 states "6' raised curb wall". Do we use Sheet/Detail A7.0/2 with a footing?

Answer: Use #2/A7.0 for the green fence foundation. There is no raised curb along the green fence wall.

Question 2: Plans call for posting spacing at 8' oc (on center) for Green Screen per Sheets/Details A7.0, A6.0/7 and Elevation A3.0/4. What is the correct Post Spacing?

Answer: The green fence post shall be spaced 8'-4" per Detail 7 on Sheet A6.0.

Question 3: What is the correct electrical panel rating?

Answer: Refer to Reference Note #4 on Sheet E0.3. The correct electrical panel rating is 225A.

Question 4: Please provide clarification regarding Circuit 10 & 12 on Sheet E0.3, Detail 3.

Answer: Replace the ordinary breaker with combination type GFCI (ground fault circuit interrupter) breaker.

Preference as stated in Section 00 01 00, 1.30, will be applied to the Total Lump Sum Bid, if applicable, to determine the final total bid amount.
