This Notice to Bidders "A" extends the bid due date and adds an additional pre-bid conference, which is hereby made part of the contract documents.

BID EXTENSION DUE DATE

This Notice to Bidders extends the bid deadline from March 4, 2025, at 10:00 a.m. to March 19, 2025, at 10:00 a.m. All bids must be submitted via BidExpress. Bids will be publicly opened at 3:00 p.m. on March 19, 2025, examined and declared by the Department of Public Works using Microsoft Teams Meeting or a County accepted Bidders may participate in the public bid opening by visiting the platform. Los Angeles County Public Works Business Opportunities website dpw.lacounty.gov/contracts/opportunities.com, selecting the project, and clicking on the bid opening link. The bid opening link will be posted March 19, 2025.

SECOND PRE-BID CONFERENCE:

There will be a second optional pre-bid conference and site visitation held on **March 6**, **2025**, **at 10:00 a.m.** at the job site to answer questions concerning the project. Interested parties are requested to meet at the following address: 16350 Filbert Street, Sylmar, CA 91342. Attendance is strongly recommended, and bidders will be allowed to bring cameras to take pictures of the project area. The County will not provide pictures of the project site. Each Bidder shall have the opportunity to take pictures at the second pre-bid conference.

The Barry J. Nidorf Secure Youth Track Facility is a closed and secure facility, and the following is not allowed inside: cell phones, clothing imprinted with lettering, pictures, or graphics pertaining to or illustrative of sex, profanity, drugs, alcohol, tobacco, illicit conduct or advocating political or religious beliefs or messages, clothing in the colors of red and/or blue, and weapons including pocket knives.

Bidders must email jhluz@dpw.lacounty.gov by March 4, 2025, at 8:00 a.m. to register to attend the pre-bid conference on March 6, 2025, with all the names of those who will attend. If bidders do not register by the aforementioned deadline, they will not be allowed inside the facility on March 6, 2025. All bidders attending the pre-bid conference must have a valid ID to enter the facility. Bidders who are unable to attend the pre-bid conference will not be able to walk the site.

This project requires the Bidder to possess a license classification of "A" or "B" at time of bid.
