

**NOTICE OF INTENT
TO ADOPT A MITIGATED NEGATIVE DECLARATION (MND) FOR THE
SWEETWATER MESA TANK AND WATERLINE PROJECT**

LEAD AGENCY: Los Angeles County Waterworks District No. 29, Malibu (District)

PROJECT TITLE: Sweetwater Mesa Tank and Waterline Project (Project)

PROJECT LOCATION: The Project site encompasses several areas within the Sweetwater Mesa system consisting of two gravity storage tanks (3311 Sweetwater Mesa Road) and associated water mains (Serra Road, Pacific Coast Highway (PCH), Sweetwater Mesa Road,), in the City of Malibu, Los Angeles County, California shown in figure 1 below.

DESCRIPTION OF THE PROPOSED PROJECT: The proposed project consists of improvements to the existing Sweetwater Mesa system to better serve existing service area. A new 12-inch water main would be constructed in Serra Road from PCH to Sweetwater Mesa Road and would continue to the new 1.12-million-gallon tank located at the end of Sweetwater Mesa Road. The new Sweetwater Mesa Tank would be located at an undeveloped District owned property (APN 4452-025-901), just north of the existing 100,000 gallon tank at 3311 Sweetwater Mesa Road. A second 12-inch water main, to replace the existing 6-inch water main, would be constructed in PCH from Serra Road to the beginning of the Malibu Lagoon Bridge, and a third 12-inch water main will be constructed along Serra Road between PCH and the existing Serra Tank. A pump station and pressure regulating stations would also be constructed for the system. Construction is anticipated to occur over a 12-month period from May 2027 to May 2028. The proposed project area is not included on lists enumerated under Government Code section 65962.5 as a hazardous waste site.
