# AMENDMENT 1 TO CONTRACT NO. 3431

## MALIBU GARBAGE DISPOSAL DISTRICT

THIS AMENDMENT, made and entered into this <u>7</u><sup>th</sup> day of <u>August</u>, 2019, by and between the COUNTY OF LOS ANGELES Board of Supervisors, acting in their capacity as the governing body of the Malibu Garbage Disposal District (hereinafter referred to as COUNTY) and Universal Waste Systems, Inc., a California corporation (hereinafter referred to as CONTRACTOR).

### <u>WITNESSETH</u>

WHEREAS, CONTRACT No. 3431 ("Contract") was entered into between the COUNTY and the CONTRACTOR, on August 13, 2018, to provide services for collection/disposal of refuse and for collection/management of recyclable material and green waste from all establishments, and industrial establishments within the COUNTY ("scope of work"), commencing on August 13, 2018; for a period of seven years with two 1½-years renewal options; and

WHEREAS, the first paragraph in Part 1, Section 7.C.1 of the Contract entitled, County Service Fees and Maximum Contract Sum, provides an incorrect reference to Attachment 7-3 for the Schedule of Prices, and further provides an incorrect reference to the not-to-exceed monetary amount of \$962,102.00. The correct reference to the Schedule of Prices is Attachment 7-5, and the correct not-to-exceed monetary amount, which should be reflected in Part 1, Section 7.C.1 is \$89,180.00, which reference and monetary amount the County desires to incorporate in this AMENDMENT.

WHEREAS, the Board delegated authority to the Director of Public Works to approve and execute amendments to incorporate necessary changes within the scope of work; and

NOW, THEREFORE, in consideration of the foregoing facts, the COUNTY and the CONTRACTOR agree that Contract No. 3430 between them shall be amended as follows:

<u>FIRST</u>: The first paragraph in Part 1, Section 7, Service Fees and Billing, C.1, County Service Fees and Maximum Contract Sum, is hereby replaced with the following:

1. <u>County Service Fees and Maximum Contract Sum</u>

County agrees, in consideration of the performance of Task 2 Services in items A, B, and E of Exhibit 3A2, to pay the CONTRACTOR County Service Fees, as specified in Attachment 7-5, Schedule of Prices Form PW-2.2.1, of Attachment 7, the **not-to-exceed amount of \$89,180.00** per Contract Year or a greater amount as the Board may approve. This is referred to as the

"Maximum Contract Sum" for Task 2 Services.

SECOND: This AMENDMENT will take effect upon execution by both parties.

<u>THIRD</u>: Except as modified by this AMENDMENT, all other terms, conditions, requirements, and specifications of this CONTRACT shall remain in full force and effect. // 11 // // // // // 11 // // // // // // // // // // //
