Re: Sunshine Canyon County Extension Findings of Conformance

Dear Mr. Aiyetiwa:

Please find enclosed three (3) sets of the following materials requested by the Task Force during the February 8, 2007 subcommittee meeting on the County Extension for Sunshine Canyon Landfill:

- A revised Section 4, Project Design Capacity, page 2 of the FOC Submittal report
- A Site Plan showing final contours and elevations of the landfill including a cross-sectional detail and profile of the disposal limit
- The Landfill Phasing Plan
- Closure / Post Closure Plans included as Section 9 of the County Extension Joint Technical Document
- Closure / Post Closure financial assurances
 - February 15, 2007 transmittal to the Waste Board including evidence of financial assurance in the form of an updated Certificate of Insurance for the County Extension
 - A March 1, 2007 letter from the Waste Board indicating compliance with Title 27

Regarding the remaining requests from the Task Force identified in your February 12, 2007 e-mail, I have provided written responses below.

- Status of Riparian and Wetland Habitat mitigation required in Condition 38 of CUP 86-312-(5)
 - Compliance with this condition was met with the construction of the Arroyo Seco mitigation project in Pasadena. The construction, maintenance, and turning over of the mitigation to the City of Pasadena followed the description below:
 - Mitigation included the development of approximately 22.5 acres of woodlands that contained 4.2 acres of stream zone and wetland.


- The construction of the mitigation was completed in September, 1998
- The mitigation project was accepted on March 12, 2003 by the Army Corp of Engineers and December 30, 2002 by the California Department of Fish and Game
- The project was turned over to the City of Pasadena in February 2004
- Status of compliance with City [Q] Condition C.9
 - A design for a mitigation project at Chatsworth Reservoir has been completed and approved by the Army Corp of Engineers and the California Department of Fish and Game. BFI is currently resolving land purchase and easement issues with the City of Los Angeles. Construction of this mitigation project will commence following the resolution of these issues.

Regarding compliance with Condition 10(b) of CUP 86-312-(5) or acceptance of the replacement CUP 00-196-(5), it is the intention of BFI / Allied Waste to "accept" the replacement CUP on or around April 1, 2007.

We look forward to attending the March 15, 2007 Task Force meeting and the receipt of the Finding of Conformance for the County Extension.
