ODOR PLAN OF ACTION – DAILY SOIL COVER**

The Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force) appreciates the October 4, 2011, letter of response provided by Mr. Thomas M. Bruen of the Law Offices of Thomas M. Bruen on behalf of Republic Services regarding daily soil cover and the Sunshine Canyon Landfill.

As you know, the Task Force requested Republic Services to substantiate a statement made in the June 24, 2011, Sunshine Canyon Landfill Odor Plan of Action, that leaving daily soil cover in place is not standard industry practice. While Mr. Bruen's letter and its attachments described the common uses of alternative daily cover materials, the response failed to substantiate Republic Services' statement.
