STAFF REPORT

SUNSHINE CANYON LANDFILL – PERMITTED TONNAGE CAPACITY

At the March 17, 2022 FPRS meeting, the Subcommittee members requested staff to prepare a Staff Report for Item VII. Update on Sunshine Canyon City/County Landfill, Permitted Tonnage Capacity. Below is the staff report for that item.

Conditional Use Permit

- Under Condition 21.A. of the Joint Sunshine Canyon Landfill Conditional Use Permit (CUP), the Landfill is allowed a maximum daily tonnage capacity of **12,100 tons** for all materials received at the landfill, or more specifically, a maximum weekly tonnage capacity of **66,000 tons** of Solid Waste and a maximum of **6,600 tons** of Inert Debris and Beneficial Use Materials. There is no provision in the CUP for a daily capacity of either material type, only the permitted daily tonnage capacity. This daily, weekly permitted tonnage is also described under Condition 4. of the Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force Finding of Conformance (FOC), dated December 18, 2008.

Republic's Tonnage Report

- Based on the January 2022 Monthly Tonnage Report prepared by Republic Services,
 - On January 19, 2022, Sunshine Canyon Landfill reported:
 - The total inbound material received for the day was approximately 11,184 tons, which is not exceeding the daily capacity of 12,100 tons per day as stated on the CUP.
 - For the week of January 17th to January 22nd, 2022:
 - The total inbound material received was approximately 52,375 tons, not exceeding the weekly capacity of 72,600 tons per week, as stated on the CUP.
 - The total Municipal Solid Waste received was approximately 43,148 tons, not exceeding 66,000 tons per week, as stated on the CUP.
 - The total Beneficial Use received was approximately 645 tons, not exceeding 6,600 tons per week, as stated on the CUP.

- On January 31, 2022, Sunshine Canyon Landfill reported:
 - The total inbound material received for the day was approximately 11,270 tons, not exceeding the daily capacity of 12,100 tons per day as stated on the CUP.
- For the week of January 31st to February 5th, 2022:
 - The total inbound material received was approximately 56,205 tons, not exceeding the weekly capacity of 72,600 tons per week, as stated on the CUP.
 - The total Municipal Solid Waste received was approximately 45,280 tons, not exceeding 66,000 tons per week, as stated on the CUP.
 - The total Beneficial Use received was approximately 1,062 tons, not exceeding 6,600 tons per week, as stated on the CUP.
- Public Works reviews the Landfill's tonnage data on a monthly basis. Based on the reported tonnages for the Month of January 2022, the Landfill did not exceed the allowable daily or weekly tonnage limits during these dates. Please note Public Works also monitors this Landfill and other Landfill tonnages to ensure they are in compliance with their respective permitted tonnages under their CUPs.
