Overview:

CalRecycle, as the Lead Agency, is preparing a Program Environmental Impact Report (PEIR) pursuant to the California Environmental Quality Act (CEQA) for [SB 54 \(Allen, Chapter 75, Statutes of 2022\)](#) Proposed Regulations.

In accordance with CEQA, agencies are requested to review the Proposed Program provided in [the Notice of Preparation](#) and to provide comments on environmental issues related to the statutory responsibilities of each responsible or trustee agency.

On July 22, 2024, CalRecycle will conduct one scoping meeting for the purposes of soliciting comments from interested parties, responsible agencies, agencies with jurisdiction by law, trustee agencies, and involved federal agencies as to the appropriate scope and content of the PEIR.
