PURPOSE OF CHAPTER 10 (in existing CSE)

- To present the procedure for obtaining a Finding of Conformance (FOC) with the Los Angeles County CSE through the Task Force (TF) for:
 - New solid waste disposal facilities
 - Expansion of existing facilities
 - “Significant Changes” to existing facilities

PURPOSE OF CSE FOC PROCESS

- Mechanism for inclusion of new or expansions of existing facilities into the CSE
- Ensure consistency and conformance with CSE and its Siting Criteria
- Provide forum for public participation in the siting process

HISTORY OF FOC PROCESS

- Pre-adoption of CoIWMP
 - CoSWMP FOC process
- Post-adoption of CoIWMP
 - CSE incorporated CoSWMP FOC process

CSE FOC PROCESS

- Applies only to permitted landfills and transformation facilities
- Provides a mechanism for inclusion of new or expansion of existing solid waste disposal facilities into the CSE
- Provides a process by which consistency with the CSE and compliance with its siting criteria are determined
- Any FOC granted by the TF would serve as an approved amendment to the CSE

ROLE OF TASK FORCE

- Ensure a coordinated approach to managing solid waste Countywide from all stakeholders.
- Active in legislative and regulatory issues
- Active in the proper siting of disposal facilities

MAJOR FOC ISSUES

- Mechanism for inclusion of new or expansions of existing facilities into the CSE
 - This FOC Purpose cannot be met due to Waste Board's decision.
 - 📁 Need authority through a JPA or similar mechanisms
 - 📁 There may be ways to address this issue

MAJOR FOC ISSUES (CONT.)

- Ensuring consistency and conformance with CSE and its Siting Criteria
 - At this point there is no other mechanism to address this purpose of the FOC.

MAJOR FOC ISSUES (CONT.)

- Provide forum for public participation in the siting process
 - Does CEQA process take care of this purpose of the FOC.

MAJOR FOC ISSUES (CONT.)

- Enforceability of the CSE FOC process
- Should the CSE FOC process be:
 - Modified?
 - Streamlined?

WASTE BOARD POSITION

- Does not recognize the FOC process as a valid means for incorporating new or expansion of existing facilities into the CSE
- Recognized “dot on the map” as the conformance process requirement
- Did not approve/disapprove CSE FOC process
- Require double majority for amendment of CSE

FOC IN FACILITY PERMIT PROCESS

- FOC/Facility Permit Process
 - See facility permit process flow chart
