## **BACKGROUND**

The Economic and Technology Advancement Advisory Committee (ETAAC or Committee) was created pursuant to the Global Warming Solutions Act of 2006, Assembly Bill 32 (AB32). The Committee was principally charged with advising ARB regarding technologies to reduce greenhouse gas emissions in California and for policies to advance development and utilization of those technologies. The Committee has developed a set of recommendations for ARB's consideration in the design of its programs to respond to AB32 and to reduce greenhouse gas emissions in California. At this Board meeting, ETAAC will present its recommendation report to the Board.

ETAAC's recommendations are intended to convey the best information gathered by the Committee over the past year, based on public input, input from experts around the world, and on their own expertise. The intent of the members is to guide the path to achieving the maximum feasible and cost-effective reductions consistent with the mandate of the Global Warming Solutions Act of 2006.

The recommendations of ETAAC are not being presented to the Board for approval or disapproval. Any set of recommendations from the ETAAC report can only form a portion of ARB's larger efforts to reduce the risk of human-induced climate change. The complete strategy will be described in the Scoping Plan which the Board must adopt before January 2009, and the ETAAC report provides information for development of that strategy.

A written report and oral statements will be presented at the meeting.
