PURPOSE OF CEQA

- The California Environmental Quality Act (CEQA) is California's broadest environmental law.
 - CEQA applies to all discretionary action projects
- Purpose of CEQA is to:
 - Disclose project impacts to public and decision makers
 - Identify feasible mitigation measures to avoid or reduce environmental impacts






PROJECT BACKGROUND

WHY REVISED and RECIRCULATED?

- A Draft IS/MND was prepared in 2013
- Public Review Occurred: 05/13/13 06/26/13
- Substantial revisions triggered preparation of the Revised and Recirculated IS/MND (Section 15073.5 of State CEQA Guidelines)
- Revisions to Project Description are disclosed and analyses are updated

CHANGES TO PROJECT IMPACTS BIOLOGICAL RESOURCES

- New potentially significant impacts were identified
 - Least Bell's Vireo incidentally observed
 - Greata's Aster observed within impact area
 - Crotch Bumblebee proposed for State listing
 - Mountain Lion proposed for State listing
 - New mitigation measures were proposed to reduce these impacts
- Updated baseline vegetation mapping (2017) for Habitat Conservation Plan
- Updated Jurisdictional Delineation (2021) to address 2020 Navigable Water Rule


- Least Bell's vireo
 - Protocol focused surveys (2012) absent
 - Protocol focused surveys (2016) absent
 - Incidental observation 2017
 - Protocol focused surveys (2018) absent
 - Mitigation Measure BIO-6
 - Pre-construction surveys
 - Protective measures

- Focused Surveys (2011); observed downstream but absent from upstream
- Focused Surveys (2016); observed downstream and upstream within sediment removal footprint
- Mitigation Measure BIO-1









GREATA'S ASTER OBSERVATION (2016) BIOLOGICAL RESOURCES



- Crotch Bumblebee
 - Potentially significant impact
 - Pre-construction survey
 - Mitigation Measure BIO-3
 - Crotch Bumblebee not listed (October 2021)
- Mountain Lion
 - No long-term change to wildlife movement
 - Less than Significant Impact


