






### Fremont Basin IRWM – Boundary Modification

- Modification: include Fremont Valley GW Basin
  - Water supply source
  - MPUD
- 166 square mile overlap with AV IRWM
  - Population overlap ~4,400







- Finalized basic update compliant with 2016 IRWM Plan Standards
  - Ready for review


