# **Stakeholder Meeting Notes**

#### A. Welcome and Introductions

 The Antelope Valley Integrated Regional Management (AV IRWM) Stakeholder Meeting was opened and led by Sami Kabar from the Los Angeles County Department of Public Works, Waterworks Division.

#### B. 2007 MOU Amendments

- The following is a status update of agencies that had not confirmed approving the MOU or submitting a Letter of Intent as of 1/23/2019 (all other agencies have either approved the MOU or submitted a Letter of Intent):
  - LA County Sanitation District (LACSD) Districts 14 and 20 scheduled for Board approval the week of January 28, MOU be executed in first quarter of 2019
  - Littlerock Creek Irrigation District approved the MOU
  - Quartz Hill Water District Chad Reed, the General Manager, said that the MOU will be on their February board agenda.
- The MOU will be executed the first quarter of 2019. The Antelope Valley State Water Contractors Association (AVSWCA) sent invoices to all the agencies.
- The A-Team met on January 16<sup>th</sup>, 2019, to discuss funding of consultant services for the full IRWM Plan
  update and development of the Prop. 1 grant proposal. The A-Team agreed to the scope of services provided
  by Woodard & Curran, which includes a full IRWM Plan update, Stakeholder Meeting attendance, and four
  grant applications (or four projects in one application) for a total fee of \$247,018.


## C. Prop. 1 Implementation Grant PSP – Updates

- Brian Dietrick contacted Holly Alpert (Program Director of the Inyo-Mono IRWMP Program) and is coordinating with her on the following topics:
  - What is the Funding Area split between Round 1 & Round 2? The AV IRWM Stakeholder Group recommends that a larger proportion of the funding be made available in Round 1.
  - What is the date for the Pre-Application Workshop? The Funding Area requested a meeting in May.
     This will set the timeline for grant application deadlines.
  - Which Regions are applying for funding in Round 1? There are 6 Regions in the Funding Area, and
    it is unknown how many will apply for funding.
  - How much is each Region requesting in Round 1? This will help determine how much funding AV IRWM will request.

### D. Prop. 1 Implementation Grant PSP – Funding and Guidelines

- The Draft PSP for Proposition 1 Implementation Grant Round 1 was released in early October. The Lahontan Funding Area (with 6 Regions) has approximately \$18.8 million remaining for Implementation Round 1 and 2.
   The proposals must meet the following requirements to be eligible for funding:
  - The Region's proposal must include at least one project that directly responds to climate change as well as one or more projects that help improve regional water self-reliance.
  - Each project must address the most critical needs of the Region, be consistent with Statewide Priorities, have a useful life of more than 15 years, and have CEQA/permits completed within 6 months of funding award or prior to agreement execution, whichever occurs first.

# E. Prop. 1 Implementation Grant PSP – Schedule and Projects



- DWR has requested a 1-day workshop with each Funding Area to provide a platform for interregional
  coordination and increase the potential for successfully completed projects. The workshop is mandatory and
  will be led by the IRWM Region representatives. The workshop will include representatives from every IRWM
  RWMG, applying entities, local project sponsors, DAC, EDAs, and Tribes. DWR will review potential projects
  and provide feedback. The Lahontan Region requested a Funding Area Workshop date in May.
- Woodard & Curran did a preliminary assessment of the existing Implementation Projects to identify projects eligible for Prop. 1 funding (Table 1). Table 1 reflects comments received at the Stakeholder Workshop; extensive project description updates have also been incorporated into the AV IRWM project database. Eligibility for grant funding can be improved with updated project information. Components used to determine project eligibility include:
  - Total project cost and requested funds
  - CEQA and permit status must be completed within 6 months of funding award or prior to agreement execution, whichever occurs first
  - DAC does the project benefit Disadvantaged Communities?
  - Technical documents are there any technical documents available?
- Projects will be selected for Round 1 at the next Stakeholder Meeting, scheduled for March 6th.
