Prop. 1 Update – Grant Administration

- Mostly complete
 - 1. Gone through two rounds of review with DWR
 - 2. Agreed on all items and permitting questions
- Final item remaining is how to address PRWA project removal
- Decision Point:
 - Redistribute funding across existing Rd 1 projects in line with previous decision to pursue most funds in Rd 1
 - Return \$881,000 from PRWA project back to funding pool for Prop 1 Rd 2 Implementation cycle (late this year)

Prop. 1 Update – Round 2 Funding Timeline

- Prop 1 Rd 2 Schedule Likely to be released at May 6 workshop
 - 1. May 6 workshop on Round 1 survey and Round 2 concepts
 - Draft PSP in Summer 2021
 - 3. Final PSP in Fall 2021
- Considering 2 application deadlines
 - 1. First deadline: Winter 2022
 - 2. Second deadline: TBD 2023
- Reminder about \$1M currently remaining for AV
